## 1 Standing Item - Membership

J Diederich referred to the Agenda for the new members not put forward at the previous meeting in August. There were 17 nominations for Ordinary membership and one Familly membership.

**Moved** P Borg and **Seconded** H King that the nominations received for Ordinary Membership and Family membership be accepted as new members of the Association. All proposed members were financial. **(Carried)**.

J Diederich referred to the great assistance provided by the Bunbury Club for the presentation and other on-course aspects. The presentation was greatly assisted by Bunbury Committee members Murray Lower and Sarah Wall, and WACHRA Vice President Bruce Jones, although no winning connections were in attendance.

J Diederich referred to the event being run with a full field of like fillies which added to the race spectacle in what produced a competitive finish.

Efforts will continue to be made to obtain a better timeslot, closer to the WA Oaks, if the existing time of year is retained.

J Diederich reported that there had been some small gains with the programming but more needed to be done. Opportunities for 3yo fillies in particular are less than desirable.

J Diederich reported on the reduction in prizemoney in Victoria and the decision made not to reduce the Group level of mares races regardless of stakes.

## 4 Standing Item – Liaison with RWWA

# 4.1 – Breeding Initiatives (Epona Proposal, HRA Breeding Report Initiatives, Other State/NZ Initiatives, Westbred Bonus Scheme)

J Diederich reported on lack of progress in developing ideas around greater support for older Westbreds. However, after reviewing schemes in other states the option of breeders having the choice of a payment of a Breeder Bonus on branding of a foal in lieu of a larger Breeder Bonus payment for a First Win (as is currently the case) was an initiative that might receive support if the analysis demonstrated no greater financial risk to RWWA.

This would not necessarily provide the immediate impact of increasing field size but could potentially encourage increased breeding numbers.

H King reported that 4 of the 9 stallions were successfully Tendered and winners advised. One stallion was withdrawn.

J Diederich advised that an attempt will be made to selectively market the remaining stallions at 80% of the service fee, or they will be passed over as it was inappropriate to provide the stallions at bargain basement prices outside the Tender period.

Committee **agreed** that WASBA stallion providers be asked to consider preferencing organisations assisting breeding activities, over clubs seeking funds for general revenue.

J Diederich referred to the forthcoming draw of 10 stallion service vouchers that will be drawn 1 October under the terms of eligibility agreed at the August Committee meeting.

#### 10 Bush Races

J Diederich referred to correspondence to both the Kulin Bush Races Committee and D Borovica (RWWA) regarding permitting older horses to compete at the picnic races.

J Diederich advised that the response from D Borovica had been very reasonable and well reasoned, and there would be no change to the age criteria under racing conditions.

J Diederich also referred to the HRCG report referencing WASBA's position on increasing the trainer percentage, and subsequent correspondence to other eligible bodies indicating that WASBA will not support any increase to trainers being taken from owners share of stakes or bonuses.

#### 14 RWWA Equine Welfare Forum 21 September

J Diederich referred to the Forum at which D Trobe will represent WASBA. The Forum is a

full day event and involves detailed pre-reading. In line with payment made by WASBA to other persons assisting WASBA with functions, J Diederich recommended that D Trobe receive some recompense.

**Moved** P Borg and **Seconded** J Fletcher that D Trobe receive a payment of \$200 from WASBA for attending the Equine Welfare Forum on behalf of WASBA (**Carried**).
